Dr. David Zaas is Associate Professor of Medicine and the President of Duke Raleigh Hospital since July 2014. Dr. Zaas previously served as the Chief Medical Officer for the Duke Faculty Practice, the Private Diagnostic Clinic (PDC). He also served as the Vice-Chair for Clinical Practice in the Department of Medicine at Duke University. He has played a major role in advancing multiple key strategic initiatives for Duke Medicine, including care redesign, clinical integration and improving access for patients. A pulmonary and critical care medicine physician by training, Zaas also formerly served as medical director for Lung Transplantation at Duke.
