Healthcare Leadership Diversity Mentoring Program Launches in North Carolina One-year program will pair 8 diverse individuals with senior executive mentors

Cary, NC – September 30, 2019 – The North Carolina Healthcare Foundation today announced the first group of participants in a new mentorship program designed to help cultivate a diverse pipeline of leaders for the healthcare field. The one-year program pairs 8 high-achieving women and men from underrepresented communities who are already employed in healthcare with five executive leaders from health systems, hospitals and the <u>North Carolina Healthcare</u> <u>Association</u> who will serve as mentors.

As both national and North Carolina demographics continue to shift, hospital and health system executives increasingly want to develop and promote diverse future leaders who can contribute different perspectives to issues and help to accelerate industry innovation and transformation.

"This new mentoring program reflects our Foundation's vision to create a North Carolina where high-quality healthcare is equitable and accessible for all. Our state needs diverse healthcare leaders to help advance those objectives, as well as to bring fresh ideas and perspectives to challenging issues like improving rural health and fixing our fragmented behavioral healthcare environment," said Julia Wacker, Senior Vice President, North Carolina Healthcare Foundation.

"Mentoring is a crucial element to creating and retaining diverse leaders in healthcare," she added. "This program is an important part of our Foundation's focus on removing barriers to advancement and supporting talented individuals with learning more about areas such as financial management, staff coaching, negotiating skills and organizational and functional leadership."
