# Meet the Candidates



**Ronnie Chatterji** received his Ph.D. from UC Berkeley and his undergraduate degree in economics from Cornell University. Chatterji is an economist and tenured professor at Duke University’s Fuqua School of Business and Sanford School of Public Policy. His expertise is in business strategy, entrepreneurship, socially responsible investing, and the intersection of business and public policy. Chatterji served as a senior economist on the White House Council of Economic Advisers during the Obama Administration. He worked on policies to strengthen our national economy, which resulted in tax cuts for small businesses, greater access to capital for entrepreneurs, and investments in economic development in North Carolina and across the nation. **Dale Folwell** has served as Assistant Secretary of Commerce, two years as Speaker Pro Tempore of the North Carolina House of Representatives, four terms as Representative to the NC House, and eight years on the WSFC School Board. He earned his BS and MS in Accounting from the University of North Carolina at Greensboro. Folwell presided over the redesign of the state’s unemployment program, resulting in chaos and confusion during the 2020 pandemic. Folwell was elected in 2016 to an open seat after failing to win the nomination to both Lieutenant Governor and Governor. His campaign was largely funded and supported by the State Employees Association, a Raleigh lobbying group representing less than 10% of the state’s employees, teachers, and retirees. <b>Will hire non-partisan experts to manage the multi-billion dollar state pension</b>	 <p>Chatterji will create the office of the Chief Investment Officer and employ only the best advisors, who will only be paid if the Pension exceeds earning targets.</p>	 <p>Immediately upon entering office, Folwell withdrew most of the pension from the market, fired the advisors who had grown the pension even in a recession, and missed \$3 billion in growth.</p>
