8:00 - 10:00am | NCHF Pre-Session – The Rural Advantage: Rethinking Pipelines and Prioritizing People

Rural communities possess untapped potential, but sustaining a local workforce requires moving beyond traditional recruitment. This panel session explores how to modernize the “rural pipeline” by creating accessible, low-barrier pathways, such as micro internships and structured mentorship, that introduce students and residents to high-visibility careers they may not yet be seen as accessible opportunities. By addressing the fundamental needs of the workforce, health systems create a culture of wellness that drives retention and positions rural employers as the gold standard of workforce support. The panel conversation will be followed by an interactive session featuring the new NCHF rural workforce toolkit. Participants will have an opportunity to provide insights about their rural community infrastructure needs and learn about resources to support North Carolina’s healthcare workforce.

The phishing email with broken grammar is dead. AI has collapsed the cost of credible, personalized social engineering — and healthcare, is uniquely exposed. This session examines what AI-enabled attacks look like. Healthcare leaders face two urgent crises: declining patient trust and escalating clinician burnout. While most organizations respond with new initiatives, technology, or policy, few address the root cause connecting both — the breakdown of human connection. In this powerful opening keynote, Dr. Anthony Orsini shows how communication is not a “soft skill,” but a strategic performance driver that impacts trust, culture, safety, and retention. Drawing on decades as an ICU physician and national speaker, he delivers practical, immediately actionable strategies leaders and clinicians can use to restore trust, reduce burnout, and bring meaning back to healthcare — one conversation at a time.

Finding the Yes: How AI Is Closing the Gap Between Patients Who Qualify for Help and Hospitals That Need to Find Them - Qualify Health

As Medicaid cuts tighten and uncompensated care rises, North Carolina hospitals face growing pressure as more patients need financial assistance and revenue cycle teams are already stretched thin. Many eligible patients go unidentified, leading to avoidable write-offs and staff burnout. Qualify Health will share how improved screening can ease this burden by handling the analysis so staff can focus on connecting patients to the assistance they qualify to receive.

Anesthesia, Access, and Cost: Fixing a Critical System Problem in Healthcare - Sound Anesthesia

Anesthesia is a fast-growing and often misunderstood healthcare cost center, with workforce shortages, rising demand, and increasing compensation straining traditional models. This session reframes anesthesia as essential perioperative infrastructure and explores how flexible staffing, aligned governance, and data-driven tools can improve coverage and throughput without major capital investment. Attendees will gain frameworks to stabilize services, reduce locums reliance, improve subsidy transparency, and position anesthesia as a driver of growth rather than a constraint.

Understanding 340B and the Current Environment - SunRx

This session will provide a strategic overview of the current 340B marketplace, past, present, and future. Highlights include the following topics: 340B history; IRA and rebate pilot program; and preparation and program strategy.

Completing the Circle of Organizational Health, Worker Wellbeing and Risk Management with Data Integration - Marsh McLennan

Employee health plays a critical role across all business lines within healthcare organizations. While data reports are invaluable, viewing them through a single lens often limits our understanding and hinders the development of comprehensive benefits packages and the measurement of health strategy effectiveness. Attendees will discover how breaking down internal silos and integrating diverse data sources can empower organizations to better understand workforce health, mitigate risks, and foster healthier outcomes.
